

## Alternative Dispute Resolution Training Programme (ADRTP)

A four-day intensive training designed for professionals interested in acquiring technical conflict management and resolution skills (practicality, processes and principles of negotiating settlements and ADR).

# Conventional Associate Training Programme (CATP)

A three-day training course for lawyers and law graduates who want to practice Arbitration as associates of NICArb.

# Fast Track Associate Training Programme (FTAP)

# NICArb Arbitration Clause For The Appointment Of A Sole Arbitrator

'The parties shall use their best efforts to negotiate in good faith and settle amicably any question or dispute, including any claim, construction, meaning or effect of this Agreement or concerning the rights and liabilities of the parties thereto or any other matter connected to this Agreement.

If the parties are unable to resolve such question or dispute within 30 days (or such further period as the parties shall agree in writing), the question or dispute shall be settled finally by arbitration in accordance with the Arbitration and Conciliation Act, Chapter A18, Laws of the Federation of Nigeria, 2004 (or any amendment thereto) and the Arbitration Rules connected thereto. The arbitral tribunal shall be constituted by a sole arbitrator to be appointed jointly by the parties in writing; if the parties are unable to agree on the choice of the sole arbitrator within seven days after the service of a notice of arbitration by one party to the other, on the application of either party, the sole arbitrator shall be appointed by the Chartered Institute of Arbitrators Nigeria Limited by Guarantee (trading as Nigerian Institute of Chartered Arbitrators). The place of the arbitration shall be Lagos, Nigeria, and the arbitration shall be governed by the laws of the Federal Republic of Nigeria. The language of the arbitration shall be English Language."

#### **MODEL MEDIATION CLAUSES**

- 1. In the event a dispute shall arise between the parties to this [contract, lease, etc.], the parties agree to participate in mediation in accordance with the NICArb mediation rules. The parties agree to share equally in the costs of the mediation. The mediation shall be administered by the ADR Centre of the Nigerian Institute of Chartered Arbitrators.
- 2. In the event of any dispute arising out of or in connection with the present contract, the parties shall first refer the dispute to proceedings under the NICArb Mediation Rules. If the dispute has not been settled pursuant to the said Rules within [45] days following the filing of a Request for Mediation or within such other period as the parties may agree in writing, such dispute shall thereafter be finally settled under the NICArb Arbitration Rules by one or more arbitrators appointed in accordance with the provisions of NICArb Arbitration Rules.
